Continuing Education Requirements: 40 hours per year.
- <u>CERTIFIED FINANCIAL PLANNER™ (CFP®)</u> –Issued by the Certified Financial Planner Board of Standards (202-379-2200, <u>www.cfp.net</u>). The CFP<sup>®</sup> designation is conveyed to financial professionals who have met rigorous professional standards and have agreed to the principles of integrity, objectivity, competence, fairness, confidentiality, professionalism and diligence when dealing with clients. Successful candidates must typically hold a Bachelor's degree, complete required course of study, hold relevant work experience, pass a background check, pass an extensive examination and comply with a code of ethics. Continuing Education Requirements 30 hours every two years.

Prior to her career at ProVise, Nancy was a shareholder and Controller responsible for accounting, claims and customer service for a privately held corporation in Northern California.
